

Terms and Conditions Policy

Terms and conditions (“Terms”) are a set of legal terms defined by E-vangeline.com. They set forth the terms and conditions governing the activities of the website visitors and the website owner. This website is owned and operated by a sole proprietor, Renate Postelmans under E-vangeline.com. These Terms set forth the terms and conditions under which you may use our website and services as offered by us. This website offers visitors clothing, accessories, home décor, and blog. By accessing or using the website of our service, you approve that you have read, understood, and agree to be bound by these Terms.

In order to use our website and/or receive our services, you must be at least 18 years of age, or of the legal age of majority in your jurisdiction, and possess the legal authority, right and freedom to enter into these Terms as a binding agreement. You are not allowed to use this website and/or receive services if doing so is prohibited in your country or under any law or regulation applicable.

Returns and Refunds:

For any undamaged product or unused product, simply return it with its included accessories and packaging along with the original receipt (or gift receipt) **within 7 days of the date you receive the product**, and we will exchange it or offer a refund based upon the original payment method. In addition, please note the following: (i) Products can be returned only in the country in which they were originally purchased; and (ii) the following products are not eligible for return: undergarments such as underwear or bathing suit bottoms, broken/damaged items not caused by shipping or manufacture prior to delivery of item to customer. All items are 100% returnable. All returns must be made within 7 days of items arrival to buyer. **Buyer must notify the seller within that 7-day timeframe of a return, by messaging the seller on seller’s website.** Simply send a message to seller on seller’s website about your intent to return an item and ship within the expressed timeframe, that way the seller has enough time to correct or come to a solution for the buyer. If buyer fails to contact seller within the 7-day timeframe, seller has the right not to issue a refund or except a return. Seller works with manufacture to correct broken/damage items or items shipped that are different than item that were marketed/purchased.

If item received is not the item that was ordered, please send a copy of your receipt and a picture of the item to the seller via message, to the seller on the seller’s website **within 7-days** after items arrival. Seller will pay for shipping and handling for return shipment if item was incorrect. Seller will issue either a refund or send buyer the correct item (if item is still available).

If item received is broken or not working upon arrival, buyer is to send a copy of the receipt and photos or a short video of the item not working properly to seller on seller’s website **within the 7-day** timeframe. Seller will pay for return shipment, and either a refund will be issued or new item (if item is still available) will be shipped to the buyer.

If buyer wants to return the item due to any other reason other than the item was broken upon arrival, not working as described, or being the wrong item received, the buyer needs to contact the seller still within the 7-day allotted timeframe. Buyer, however, will be responsible for the shipping and handling of the returned item otherwise no refund will be given.

Note: All refunds and reimbursement of return shipping will be delivered upon completion of the items return, and after the 15-day processing period has been completed. Seller’s website is <https://www.E-vangeline.com>.
